

## **GENERAL GUIDELINES:**

Appointments must be made in advance. Please fill out the photographer's reservation form on our website. We will reply and confirm your appointment.

CM Farms reserves the right to prohibit business disruptions to daily operations due to photography sessions or to regular customer activities. If any fixed or temporary objects are moved or damaged during session, photographer will be held responsible for replacement and or payment

Photographer and photographer's clients will hold harmless CM Farms any injuries sustained during photography sessions and are not responsible for injury for any poses or requests by photographer during sessions.

## **FEES:**

- \$300 - Whole Day (8 hours)
- \$160 - Half Day (4 hours)
- \$50 - 1 hour
- Includes admission for photographer and one assistant.
- Photographers and clients MUST check-in at our Admission Building upon arrival. If there is a line at the Admission Buildings, photographers and clients may check in at the Country Store.
- Upon check-in, photographers must pay for their expected time at the farm, sign the photography agreement and leave their driver's license.
- Upon check-in, clients must pay \$10 farm admission (discounted rate). \*The photographer MUST give their client something to show they are here for a session to be able to get the discounted admission.
- Photographers will be provided a name tag upon receipt of payment. Please return the name tag upon departure and the driver's license will be returned after any possible remaining balance is paid, based on hours at the farm.
- We accept cash, Visa, MasterCard, Amex, and Discover.

## **IMPORTANT REMINDERS:**

- Please be courteous and polite to all visitors and customers.
- There is a \$10 farm admission (discounted rate) for EVERYONE who enters the farm. Clients can then enjoy the farm after the shoot.
- The photographer MUST give their client something to show they are here for a session to be able to get the discounted admission.
- All props must be removed upon departure.
- Be aware of insects, stickers, fire ants, etc. in this natural environment.
- We have an area of the corn maze that we have special for photographers to set up that will offer them a more secluded and private area for their shoots.
- No public area may be closed or blocked to customers during regular business hours during a photoshoot.
- Vehicles are NOT allowed in the corn maze or any other part of the farm. All props, furniture, etc. must be carried to your photoshoot location. We recommend bringing a wagon to transport props and other items.
- CM Farms staff is not responsible for directing clients to your photoshoot location. Make sure your clients have your cell phone so that they can contact you upon their arrival.

THIS INDEMNITY WILL ARISE UPON ANY ACTION OR SUIT OR CLAIM FOR LOSS, DAMAGES AND COSTS WHATSOEVER ARISING OUT OF RELATED TO ARISING OUT OF, OR IN ANY WAY CONNECTED WITH, MY CLIENT'S PARTICIPATION IN ACTIVITIES OR PRESENCE UPON THE PREMISES OF THE FARM. THE COST HERE INDEMNIFIED INCLUDE, BUT ARE NOT LIMITED TO, ALL COSTS, EXPENSES AND FEES ARISING OUT OF AND CONNECTED WITH THE FARM'S DEFENSE AGAINST ANY CLAIM RELEASED, DISCHARGED, AND UPON WHICH PROMISE HAS BEEN MADE NOT TO SUE OR MAKE A CLAIM.

I HAVE READ THIS DOCUMENT AND AGREE TO ALL OF ITS TERMS, GUIDELINES, FEES AND POLICIES REGARDING PHOTOGRAPHY SESSIONS. I UNDERSTAND IT BECOMES A LEGALLY BINDING CONTRACT UPON EXECUTION BY THE FARM AND THAT IT WAIVES CERTAIN LEGAL RIGHTS OF MINE, MY EMPLOYEES AND OF MY CLIENT(S) INCLUDING BUT NOT LIMITED TO A RELEASE, DISCHARGE, INDEMNIFICATION, PROMISE NOT TO SUE, AND HOLD HARMLESS FROM ALL CLAIMS THAT CAN BE MADE AGAINST THE FARM AND ITS OWNERS, AGENTS, CONTRACTORS, AND EMPLOYEES. IT IS THE INTENT OF THIS AGREEMENT THAT IT SHALL BE BINDING UPON MYSELF, MY EMPLOYEES, MY CLIENT(S) AND ANYONE ATTEMPTING TO ACT ON BEHALF OF MY EMPLOYEES, CLIENT(S) AND OUR ESTATES SUCCESSORS AND ASSIGNS.
